As a partner with Fitzwater Law, my practice focuses on all aspects of estate planning and administration, including planning for high-net worth clients with estate/gift tax concerns, blended families and planning for people with special needs. But while I had a great view of the San Francisco bay from my office window, I missed my traditional estate planning practice and having a more direct relationship with clients and their families and I began looking for other opportunities. My husband had grown up in the Pacific Northwest and we had spent many weekends visiting with friends and family in Portland. In 2002, we decided to make Portland our home.
